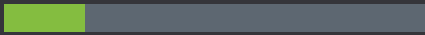


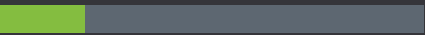

Responsibilities included soil sampling, subcontractor supervision and weekly reporting.

This included identifying data gaps during an initial desktop assessment, fieldwork management and assisting with reporting. Site works involved an extensive, quick turnaround investigation including soil and groundwater sampling.
- **Environmental Scientist, Roche Products, Environmental Monitoring, New South Wales.** Priya supervised a quarterly monitoring program covering areas of groundwater and soil vapour, which included supervising on site drilling operations and contractor management. Responsibilities also encompassed ensuring appropriate OH&S mitigation measures are in place for the overall safety of workers, site visitors and the public.
